STABLE Visa Cards are a wonderful feature of ABLE New Mexico accounts. The cards are available to all ABLE New Mexico account holders and their Authorized Legal Representative (ALR), but must be requested.

Funds are loaded onto STABLE Visa Cards and can be used anywhere Visa is accepted.

True Link Financial recently shared the following account spending trends which highlight how ABLE account owners use their cards and some of their expenditures.

We are very pleased to announce that on December 9, 2021, the **National Association** of State Treasurers

(NAST) membership voted unanimously to revise the NAST Constitution to create an ABLE Network within the association.

The following will be added:

Article V

Section 4.1. The Achieving a Better Life Experience (ABLE) Network.

In 2021, the ABLE Network was established under NAST. This is a Most account beneficiaries use their cards for day-to-day spending.

- 7 purchases per month on average
- \$17 is the median amount of a purchase with an ABLE card
- 64% of purchases are made by the beneficiary
- Top 3 spending categories: shopping, groceries, and phone/TV services
- Top 3 merchants: Amazon, Wal-Mart, & McDonald's

ABLE card users have the option to add notes to their online transaction records, adding context to

network of state officials who administer Section 529A programs and is dedicated to enhancing the communication, cooperation, and effective administration among the plans. The Network also seeks to influence the setting of national policy affecting Section 529A programs and those saving for the needs of people with disabilities. expenditures, such as:

- Wheelchair van battery
- Shower chair
- Haircut with highlights
- Medical care for service dog
- Sweater for graduation
- October cell phone bill
- Lunch with boyfriend
- Private music therapy session

Impaired driving includes distracted driving, drugged driving, and drunk driving.

December is one of the busiest and most dangerous on the nation's roads. With the holidays comes an increase in social events that involve alcohol, and National Highway Traffic Safety Administration data show that this results in an increase in DUIs and fatal drunk-driving crashes.

Tie One on for Safety[®] Tie One On For Safety[®] is MADD's longest-running Designated Driver Campaign.

Now in its 35th year, Tie One On for Safety[®] originates from the phrase "tie one on," which is slang for drinking alcohol.

At MADD, we use the phrase to remind everyone that drinking and driving don't mix, and to always designate a nondrinking driver.

Every holiday season from November 1 through December 31, MADD asks you to display a MADD ribbon in a visible location to remind everyone to always designate a nondrinking driver. That message is especially important when holiday travel, parties, and family gatherings put more people on the roads.

This year, MADD and National Presenting Sponsor Waymo are celebrating the 35th Anniversary of the Designated Driver. You can help us create a nation of No More Victims by always taking personal responsibility for getting yourself and your loved ones home safely.

How Can You Participate in Tie One On For Safety[®]?

You can help by tying one on for safety this holiday season display a MADD red ribbon, magnet, or decal on your vehicle.



And remember:

- Put safety before the party; plan ahead and always designate a non-drinking driver
- Never ride with someone who is impaired
- Choose to be the nondrinking designated driver
- Host parties that include mocktails and other nonalcoholic beverages and provide alternate transportation or accommodations for quests who choose to drink

Together, we can put an end to this 100% preventable crime and make this holiday season safer for our loved ones on the roadways.

8 PARTY TIPS TO HAVE A SAFE HOLIDAY GATHERING.

The holidays are a time for friends and family. Here's how you can help protect your friends and family this holiday season as we celebrate 35 years of the Designated Driver.



As guests RSVP, confirm that they have a plan for a safe way home via a non-drinking designated driver, such as a friend, rideshare service like Uber or Lyft or public transportation.



Plan activities like party games or door prizes that do not involve alcohol. Incorporate a theme and consider those guests that do not drink alcohol.



Provide other beverage options (i.e. sodas, non-alcoholic ciders, hot cocoa, or coffee). Make the other options entertaining! Create a hot cocoa bar, a custom coffee bar set up or build your own ice cream soda option. Drinking at parties is not required to have a good time and being creative with non-alcoholic options can be fun and festive!



Provide plenty of food to keep your guests from drinking on an empty stomach.



Create a themed "mocktail" for a fun alternative for your non-drinking designated drivers and others who prefer not to drink alcohol.



Never serve alcohol to someone under 21 and never ask anyone under 21 to serve alcohol at parties.



Remember that only time sobers a person up, which means you may need to offer the sofa or guest room to guests who should stay put for the night.


